

Included in your hunt price is the 8.5% Chautauqua County Sales Tax I am required to collect on the taxable portion of your hunt package. Since 2013 I have been covering this cost not wanting my guests to feel they are being "nickeled and dimed" to death with extra charges.

Deposit(s) received from hunter must total 500 dollars for the hunt to be considered BOOKED and unless other arrangements are made 50% of the hunt cost must be paid by April 1st.

HUNTER'S RESPONSIBILITIES:

- (a) Provide transportation to and from the hunting lodge in Sedan, Kansas. Provide his or hers personal items, hunting equipment, gear, and alcoholic beverages if desired. Alcohol and mixers not provided by Caney Creek Outfitters, LLC.
- (b) The Hunter shall be responsible for completing all paperwork and paying all necessary fees for applications, licenses, and permits. For adults; deer tags are 442.50 and the adult non-resident annual hunting license is 97.50. If the hunter is under 16 yrs. old the deer tags are 117.50 and the annual youth hunting license is 42.50.
- (c) The Hunter is responsible for obtaining the appropriate license from the State of Kansas and is responsible for being legally authorized to hunt, including a hunter's safety permit for a hunter born after July 1, 1957. IF THE HUNTER IS UNABLE TO HUNT BECAUSE OF NOT HAVING OBTAINED THE APPROPRIATE LICENSES AND PERMITS, ALL FEES PAID BY THE HUNTER TO CANEY CREEK OUTFITTERS SHALL NOT BE REFUNDED.
- (d) The Hunter must contact Jerry Meacham for unit selections and apply as instructed for their Unit 12, whitetail, either sex, deer tag, issued for the correct weapon type and season, during the application period which is during the month of April. Hunter will receive a full refund if permits properly applied for are not issued by the Kansas Wildlife and Parks.
- (e) Caney Creek Outfitters makes no guarantees or warranties, either expressed or implied, as to the fitness or purpose of the property and the success of the hunting is strictly the risk and responsibility of the hunter.
- (f) Hunter agrees to hunt or fish in a manner consistent with Kansas fish and game laws and regulations and abide by camp and hunt rules as dictated by Caney Creek personnel. Hunter understands they are personally responsible for law violations they commit.
- (g) Hunter is responsible for costs associated with processing, shipping, storing, and transporting meat or trophies from the lodge. Caney Creek shall not be liable for shippers', meat processors, taxidermist negligence,
- non-performance, abuse, damage, spoilage, or theft or loss of any of the Hunter's property.
- (h) Hunter assumes all risks known and unknown relating to the hunt and releases and covenants with Caney Creek, as part of the consideration of this contract, not to make any claim against Caney Creek resulting from the hunt.
- (i) Any and all feeders, tree stands, blinds, game cameras, or any other equipment must not be moved or modified by the Hunter unless prior consent is given by Caney Creek Outfitters.
- (j) No smoking allowed in tree stands, ground blinds, and/or shooting towers. All trash, chewing tobacco, urine bottles, and any other debris left by Hunter shall and must be removed each time prior to leaving your stand.
- (k) In the event that the Hunter should desire to terminate the hunt, before or after the hunt has begun, no refund of any fees will be made.
- (I) Caney Creek Outfitters is not responsible for loss of hunting time, lodging, flight delays or any other losses incurred due to acts of God, weather, governmental action, or other conditions beyond our control. WE RECCOMEND THE HUNTER PURCHASE TRAVEL AND TRIP INSURANCE FOR SUCH EVENTUALITIES.
- (m) Under no circumstance is the Hunter allowed to go scouting, walking, or site seeing while in the field. Hunter shall walk from vehicle to stand and from stand to vehicle only. Should the Hunter shoot a deer, the Hunter is not to search or attempt to recover the deer until Canev Creek has given the consent to do so.
- (n) Hunter agrees to accept and abide by the provisions of the contract and pay all fees when due.
- (o) Hunter agrees to hunt a mature deer and not take a "consolation" buck at the end of the hunt.
- (p) Hunter agrees to refrain from consuming any alcoholic beverages during the hunting day.
- (q) Hunter agrees to read, sign, understand, and accept the release of liability and hold harmless agreement.
- (r) Photos of Hunter at the lodge and of game taken may be used for advertising by Caney Creek Outfitters.
- Items "found" on our owned and leased land such as antlers, on or off the skull, are the property of Caney Creek.
- (s) All wounds will be treated as a harvested deer, unless and until Caney Creek Outfitters has determined, at their discretion the wound to be or not to be fatal.

CANEY CREEK OUTFITTERS SHALL PROVIDE HUNTER:

- (a) Guide service, accommodations, meals, deer stands of various types, transportation of the Hunter up to twice daily to and from the hunting location. Caney Creek Outfitters shall be responsible for all field care of deer. We will deliver Hunters deer to the local processor or you may process your own deer in our facility.
- (b) Caney Creek Outfitters provides Hunter a archery range and a rifle range at the lodge.
- (c)This agreement is deemed made at outfitter's place of business in Brevard County, Florida.

Any dispute arising from this contractual relationship shall be governed by Florida law, and shall be decided solely and exclusively by State or Federal courts located in Brevard County, Florida. Any party who unsuccessfully challenges the enforceability of this forum selection clause shall reimburse the prevailing party for its attorney's fees, and the party prevailing in any such dispute shall be awarded its attorneys' fees."
